
Kokomo "Castaways"

From the Desk of Scott Niss

Many of you are probably aware of our recent computer upgrades at Associated Finishing. I'm happy to report that the transition was smooth and that we are already benefiting from the many improvements our new system has to offer. One of the most recent applications has been in the way we collect our data on the orders being finished out in the shop.

In the past we have relied upon our time clocks to assist employees in recording the beginning and completion of a particular order. Office staff would tally up all the time logged in on each job on the following day. As you can imagine, this process was very time consuming and meant our information was always one or two days old by the time it was available to us.

Now, employees clock in and out of orders through computer terminals located at their worksite. This gives us live, up-to-the-minute information on what is happening with each order being processed throughout the plant. It is easy for us to access should any questions from our customers need to be answered.

However, we are going to need your help for this system to be effective. Each order must be entered into the system BEFORE any work is begun on it! It is imperative that we get advanced notice from each customer on all orders coming into AFI. The information we receive will make it possible for us to have all needed data in our computer, so that work can begin on your parts as soon as they enter our plant.
